Description			
Provide a short description of the event and its activities.			

The 4th TPM took place in Larissa, Greece on 2-5/5/23 and the topic under discussion was the different ways of bringing closer the European participation mechanisms to young citizens.

Partners analysed the various problems that face young citizens regarding their participation in democratic life with the focus being mainly on the motives that should be provided to young people to ensure their commitment and involvement in the political scene of their country. This was achieved through the Working Sessions “Municipalism beyond EU capital cities” and “Cinema – forum debate on the participation of young people in EU politics”, where all partners presented their experience on how local administration tries to enforce civic participation of the youngsters.

During the meeting, partners also explored the different possible ways to avoid this “Lack of connection between civic participation and youngsters” (3rd Working Session). Challenges that need to be addressed are the same and partners highlighted the need of reaching out the youth with means that are suitable and in accordance with their everyday life.

At the meeting closure there was a coordination session by the lead partner where the current financial status, communication dissemination activities and the next steps – upcoming events were discussed.
